



2.5% Classification Anomaly and Compensation Comparability Wage Increase effective April 1, 2016

CSSEA and CSSBA agreed that in the first year of comparability, all job classifications would be eligible for a 2.5% increase in wages effective April 1, 2016. Wage schedules outlining the new hourly wages are attached and reflect the application of the first year of comparability increases.

All job classifications with comparable Community Health jobs will receive this year's compensation comparability adjustment, as agreed at the bargaining table. To maintain the existing job and pay hierarchy, all remaining classifications that do not have a comparable Community Health job will also receive a 2.5% increase in wages on April 1, 2016. These additional increases will be paid from the anomaly funds negotiated by the parties.

The Joint CSSEA and CSSBA Committee will continue to meet this year to determine future wage adjustments scheduled for April 1, 2017 and April 1, 2018. Future compensation comparability and classification anomaly wage increases may result in different percentage increases for some classifications. To be eligible for comparability money, a classification must meet the following criteria to qualify for a wage adjustment:

- The classification must have a comparator classification in the Community Health Collective Agreement and be on the attached list in the collective agreement;
- The difference in the wage rates is adversely affecting recruitment and retention and the provision of service to clients;
- There is a reasonable expectation that a wage adjustment will reduce this adverse impact;
 and
- The adjustment will not create additional cost pressures on other public sectors.

As the criteria are affected by changes to classification and corresponding wage rates in the Community Health Collective agreement, any future decision by the Joint CSSEA and CSSBA Committee will also take into consideration the outcome and timing of the compensation comparability adjustment in Community Health to the Facilities Subsector Agreement.
